



FRED KAUFFMAN "Other than my parents, the individual who first comes to mind is Judge Robert Von Pelt, a federal district judge whom I clerked in 1964-1965. He provided insights to me on what it meant to be a servant leader, together with showing me insights into a professional and personal life that was guided by integrity, honesty, diligence and dedication. This was consistent with parental teaching, but coming from the world around me it was both confirming and inspirational."



TEAMMATES is a school based, one-to-one mentoring program. We recruit community members to volunteer one hour per week within their local schools. The volunteer serves as a positive role model for a young person who could benefit from another caring adult in their life. We are currently in 73 communities throughout Nebraska and Iowa and 2,800 students are active in the program. The mentors matched with these students are making the difference of a lifetime one hour at a time.

Tom and Nancy Osborne founded the TeamMates Mentoring Program in 1991 in an effort to provide support and encouragement to school aged youth. The goal of the program is to see youth graduate from high school and pursue post-secondary education. To reach this goal, youth meet one hour per week with a caring adult who serves as a mentor. Mentors are caring adults from the community who have dedicated themselves to making a difference in the life of a young person. Mentors give youth a sense of hope, purpose and vision.







## MENTOR JOB STATUS


